## Section 5 - Stability and Reactivity

**Stability:** B-12 Chemtool All Season Diesel Fuel Treatment is stable at room temperature in closed containers under normal storage and handling conditions.

Polymerization: Hazardous polymerization cannot occur.

Chemical Incompatibilities and Conditions to Avoid: Isolate from oxidizers, heat, sparks, electric equipment and open flame. Hazardous Decomposition Products: Thermal oxidative decomposition of B-12 Chemtool All Season Diesel Fuel Treatment can produce carbon monoxide, carbon dioxide and various hydrocarbons.

## **Section 6 - Health Hazard Information**

### **Potential Health Effects**

Primary Entry Routes: Skin, dermal, inhalation and ingestion.

Target Organs: Eyes, skin, respiratory system, CNS and lungs.

Acute Effects: May cause irritation to the eyes, skin, nose, throat and respiratory system. Nausea, headache, weakness, reatlassness, in accordination, drougings, yamiting, diarrhea and dermetitis. Harmful ar fatal if swallowed

restlessness, in-coordination, drowsiness, vomiting, diarrhea and dermatitis. Harmful or fatal if swallowed.

#### **Emergency and First Aid Procedures**

Inhalation: Remove to fresh air. If not breathing, give artificial respiration. Get medical attention immediately.

Eye Contact: Immediately flush eyes with plenty of water. Get medical attention, if irritation persists.

Skin Contact: Immediately wash skin with soap and plenty of water. Remove contaminated clothing. Get medical attention if symptoms occur. Wash clothing before reuse.

Ingestion: GET MEDICAL ATTENTION IMMEDIATELY. Do not induce vomiting.

After first aid, get appropriate in-plant, paramedic, or community medical support.

## Section 7 - Spill, Leak, and Disposal Procedures

**Spill /Leak Procedures:** Eliminate all sources of ignition. Stop spill at source. Wear appropriate personal protective equipment (Sec. 8). Contain the spill to facilitate cleanup with absorbent. Use non-sparking tools and equipment. Transfer to disposal containers.

**Containment:** For large spills, dike far ahead of liquid spill for later disposal. Do not release into sewers or waterways. **Disposal:** Contact your supplier or a licensed contractor for detailed recommendations. Follow applicable Federal, state and local regulations.

Regulatory Requirements: Follow applicable OSHA regulations (29 CFR 1910.120).

## **Section 8 - Exposure Controls / Personal Protection**

**Ventilation:** Provide general or local exhaust ventilation systems to maintain airborne concentrations below OSHA PELs (Sec. 2). Local exhaust ventilation is preferred because it prevents contaminant dispersion into the work area by controlling it at its source.

**Respiratory Protection:** Seek professional advice prior to respirator selection and use. Follow OSHA respirator regulations (29 CFR 1910.134) and, if necessary, wear a MSHA/NIOSH-approved respirator. Select respirator based on its suitability to provide adequate worker protection for given working conditions, level of airborne contamination, and presence of sufficient oxygen. For emergency or non-routine operations (cleaning spills, reactor vessels, or storage tanks), wear an SCBA. *Warning! **Protective Clothing/Equipment:** Wear chemically protective gloves, boots, aprons, and gauntlets to prevent prolonged or repeated skin contact. Wear protective eyeglasses or chemical safety goggles, per OSHA eye- and face-protection regulations (29 CFR 1910.133). Contact lenses are not eye protective devices. Appropriate eye protection must be worn instead of, or in conjunction with contact lenses.

Safety Stations: Make emergency eyewash stations, safety/quick-drench showers, and washing facilities available in work area. Contaminated Equipment: Separate contaminated work clothes from street clothes. Launder before reuse. Remove this material from your shoes and clean personal protective equipment.

**Comments:** Never eat, drink, or smoke in work areas. Practice good personal hygiene after using this material, especially before eating, drinking, smoking, using the toilet, or applying cosmetics.

**Handling Precautions:** Avoid prolonged breathing of vapor and contact with eyes, skin and clothing. Use in well ventilated area. Wash thoroughly after handling.
